Sexual Assault- C.R.S. 18-3-402(1)(b) a Class 4 Felony as amended;
Stalking 2 counts- C.R.S. 18-3-602(1)(c) a Class 5 Felony as amended;
First degree Criminal Tampering- C.R.S. 18-4-505 a Class 1 Misdemeanor as amended.

And I ask the court to issue a warrant for her arrest.

The facts establishing probable cause to believe that the criminal offenses were committed and that the above named person committed the offenses and showing grounds for the issuance of an arrest warrant are as follows:

On 02/21/2017 I received a call from an advocate at Colorado State University (CSU) requesting help with a sexual assault investigation. The advocate brought _____ and _____ to Fort Collins Police Services. _____ and _____ told me that they had been texting with two guys and now they believe the person texting them is actually Jalen (JJ) Perez (DOB: 02/10/1997), a girl who _____ during the 2015-2016 school year. _____ said JJ sexually assaulted her in September 2016. _____ said she didn't report it because the guys _____ she was texting with convinced her that it wasn't wrong. _____ said she knew what happened was wrong. _____ said she cut off contact with JJ, but was continuing to text with the guys. _____ and _____ said in the last few days they figured out the connection with

everything.

and [redacted] said they moved off campus in the fall of 2016 to [redacted] in the City of Fort Collins, County of Larimer, State of Colorado. [redacted] said in November 2015 she, [redacted] and JJ were doing homework in their dorm room. [redacted] said she got a notification on Instagram that a guy named [redacted] wanted to follow her on Instagram. [redacted] said JJ told her he was a friend of hers from high school in Colorado Springs. [redacted] said since they had a mutual friend she accepted the request for him to follow her on Instagram. [redacted] said they talked back and forth on Instagram and eventually exchanged phone numbers and began texting. [redacted] said [redacted] told her he went to CSU and told her all about himself. [redacted] said [redacted] was looking for a boyfriend and asked [redacted] if [redacted] knew anyone. [redacted] gave [redacted] his friend [redacted] name and then [redacted] and [redacted] began texting. [redacted] said she and [redacted] were texting all the time. [redacted] said she and [redacted] tried to meet up several times, but there was always a problem on [redacted] end. [redacted] said [redacted] and [redacted] tried to meet up several times and [redacted] was always unable to meet.

[redacted] said she used to go to the Sundance bar with [redacted] and JJ, and one night JJ pointed out [redacted] and [redacted] as they were leaving. [redacted] said JJ was always seeing [redacted] or [redacted] places, but when the girls wanted to go over to see them JJ would pull them back and have a reason why they couldn't. [redacted] said [redacted] would know what she was wearing or who she was with, but these situations always happened when she was with JJ. [redacted] said it didn't make sense that JJ would see the guys and then they wouldn't come over and talk to them.

[redacted] said she is still in contact with [redacted] said she recently sent [redacted] a message telling him to listen to a song she liked. [redacted] said she and JJ used to listen to Spotify together and that same day she looked on JJ's Spotify account and saw that JJ had added the song [redacted] told [redacted] about. [redacted] said the night before at around 10:14pm she texted [redacted] that she liked the singer Cody Johnson and a certain song of his. [redacted] said at 10:30pm she went on JJ's Spotify account and saw she was listening to Cody Johnson. [redacted] said there was another guy named [redacted] who was supposedly a friend of [redacted] and [redacted] who she was also texting. [redacted] said there is a school directory and they looked up [redacted] and none of them go to CSU. [redacted] said [redacted] told her he was in a fraternity. [redacted] said she knows [redacted] guys from that fraternity and none of them know [redacted] said the guys knew things about CSU that only a student would know like when certain labs are offered. [redacted] said JJ is the only person they know who has seen

[redacted] said they discovered that the phone number she had for [redacted] and the number [redacted] had for [redacted] were the same number. [redacted] said there were lots of red flags with [redacted] so she tried to end things with him. [redacted] said when she did this [redacted] told her that if she wasn't in his life then his life was worthless and he became suicidal. [redacted] said she kept texting "stop" to [redacted] and then she got a notification asking if she wanted to stop texts from the Pinger app. Pinger is a texting app. [redacted] said the next day [redacted] apologized and she asked him why he was texting her from an app and he

told her his mom didn't want him texting a lot. said she was upset he was texting her through an app and asked him for his actual number. told he would give her his real phone number when they met in person. said she thought was texting her through an app too.

said JJ would tell them that she had talked to the guys in person on certain days and that made them think they were real. said JJ always wanted her to drink when they would go out and said sometimes she liked to go out and just be sober. said JJ was manipulative and they would fight about this. said JJ wouldn't drink and would say she was going to "take care" of said one night in September 2016 she and JJ went to a party. said they drank a little before the party and then took an Uber or Lyft to the party. said she took a shot that was Everclear and it was a lot for her to drink so she told JJ she needed to go home. said JJ kept asking her at the party if she was "blacked". said one of their friends drove them back to her apartment. said she heard them get home and she could tell had a lot to drink.

said she and JJ talked to her other roommate, and then went into room. said she didn't remember changing, but knew she got into a T-shirt and out of what she wore out. said she remembered getting in bed. said she was lying on her side facing the wall and she remembered JJ was rubbing her back. said the next thing she remembered she was laying on her back. told me it was coming back to her and then put her face in her hands and began crying. said she remembered JJ telling her she would be so mad at her if she wasn't "blacked" while was lying on her back. said she remembered being on her back and JJ's hand was in her underpants and JJ's fingers were inside of her vagina. said the next thing she remembered her hands were down at her sides and her shirt was up and JJ was on top of her. said her hands were down and trying to move. said the next day she was supposed to spend the day with JJ. said in the morning JJ was asking her what she remembered about the night before. said she remembered things, but didn't say and instead said she was going to stay home.

said texted her that morning and she told him what she thought happened. said told her he had to work in the vet clinic all day. said this was the only time had been unavailable to text her all day. said later in the day JJ texted her. said JJ apologized and said she knew couldn't trust her anymore. said JJ said something about knowing didn't want to, but she was drunk. said later was telling her JJ did nothing wrong so she didn't speak up. said was asking her if she knew about it and she asked if she could tell him she knew and then right away texted and asked her why she told said initially they thought JJ was feeding the guys information. said after the assault she tried to spend time with JJ, but then she told her she couldn't do it. said one day she was talking with JJ and JJ told her she didn't think what she did was wrong. said this made her worry JJ would sexually assault her again. said it was confusing because she

had the boys telling her she was actually in the wrong for not giving JJ a second chance.

said she received a text message from JJ the day after the sexual assault. showed me this text message which was sent on 09/17/2017 at 8:29pm. The message says:

"Hey I honestly am not exactly sure what to say and I wish I knew. I just want to apologize. Like the biggest apology ever. I know you probably don't ever wanna see me again which I definitely understand and don't blame you for. You're my best friend and I love you for that. You've always been there for me and I can always trust you and I'm just sorry I fucked up so bad and let all that happen and now you can't trust me. I keep trying to convince myself it's whatever we were drunk, but it's not whatever. You deserve a better friend and I wasn't that for you last night. I love that I'm always the one you can count on, and I know you don't think that anymore. I can't make any excuses, there aren't any. I shouldn't have let things get that out of control. I don't want to lose you and honestly the huge probability that I did lose you has been killing me all day and literally today has been one of the worst days of my life. I don't expect you to accept this apology now, or ever. But I just wanna let you know how sorry I am. Genuinely deeply sincerely sorry you don't have to respond, I definitely wouldn't if I were you. It's probably better you don't respond. If anything just know I will never ever let anything like that happen again or ever come close to it. I'm sorry."

On 02/23/2017 came to the police department to attempt a pretext phone call. asked JJ if she could tell her what she remembered, and JJ said she had been trying to block out what happened. said she remembered JJ asking her if she was "blacked". said JJ hurt her and she didn't want those things to happen and that JJ knew she didn't want those things to happen. JJ said she didn't want it to happen either. asked JJ if she thought what she did that night was wrong and JJ said "Yes", "it was completely wrong". JJ asked why she thought she had apologized a million times. JJ said neither of them wanted to be in that situation.

told JJ it felt like JJ raped her. JJ said she didn't do that. told JJ she didn't respect her that night. asked JJ if she was sorry for what happened that night and JJ said "for the millionth time I am sorry". asked JJ if she was sorry for touching her and JJ said "yes I am extremely sorry." JJ said she 100% percent remembered asking "is this okay multiple times". said that was not what JJ told her by text the next day. said the only story she had about what happened was what told her. told JJ she took something from her that night. JJ said she was sorry and would continue to be apologetic because she knew it was wrong.

On 02/27/2017 JJ came to the police department to speak with me. I asked JJ if there was anyone had to talk about things with and JJ said she thought she had her boyfriend I asked JJ about boyfriend and JJ said she didn't know him well. JJ said net him through a guy was talking to. JJ said she knew he went to CSU and she had seen him around a few times. I asked JJ if he lived on or off

campus and JJ told me he lived off campus and he worked for the vet clinic.

I asked JJ when it was that she and [redacted] went their separate ways and JJ said it was a gradual thing. I told JJ I understood there had been a phone call between she and [redacted] recently and JJ said it was "very odd." JJ said [redacted] told her she wanted closure about the friendship. JJ said [redacted] hung up on her and told her not to call or text her again.

I told JJ that [redacted] told me about a night they had gone to a party in September and [redacted] was drinking and had gotten pretty intoxicated and then they went back to [redacted] apartment. I asked JJ if she remembered that and JJ said she thought so, but she wasn't sure how it was relevant. I told JJ that [redacted] told me about some things that happened in her bedroom and JJ told me they kissed, but didn't know how that was relevant. I told JJ that [redacted] was intoxicated and she had some memory gaps. JJ said [redacted] was having stomach pain and asked her to rub her back. JJ said [redacted] was talking about her boyfriend and she wanted him there. JJ said she wasn't sure if [redacted] leaned in. JJ said it was a short kiss and then [redacted] fell asleep. JJ said she left in the morning to see her family. I asked JJ if this was when the separation between them happened and JJ said now that I mentioned it, this was when that happened. I asked JJ if anything other than kissing happened and JJ said no because it was odd. I asked JJ if this was some of the stuff [redacted] brought up when they talked on the phone and JJ said not specifically.

I told JJ that [redacted] remembered JJ fingering her and JJ said "really". I told JJ that the next thing [redacted] remembered, JJ was on top of her and her shirt was up and JJ was telling her that she would be pissed if she wasn't "blacked". JJ said she was really confused by that. I asked JJ if that was what she was apologizing to [redacted] for the next day and JJ said she was apologizing for the kiss. I told JJ that it sounded like she texted with [redacted] boyfriend after this and JJ said yes. JJ said she told [redacted] about the weird kiss. JJ said [redacted] said [redacted] was pretty upset about it. I told JJ that [redacted] brought these things up when they talked on the phone and JJ said she did not remember that. I told JJ that [redacted] told her that she thought she raped her and JJ said "really" and "wow" and asked if this was what this was about and said she didn't rape her. JJ said [redacted] was her best friend and she would never do anything to hurt her. I told JJ that after that phone call [redacted] got texts from [redacted] and JJ said she didn't text [redacted]. I asked JJ if she still had any conversation on her phone from him. JJ said she did talk to [redacted] friend [redacted], but that was by phone. JJ pulled out her phone and showed me her text messages. I did not see any text messages with [redacted] or [redacted]. I asked JJ how she contacted [redacted] and she said she called him. I asked JJ if she had a record of that call. JJ went to her call log and showed me the call from [redacted]. There was no call with [redacted] on the call log.

I told JJ a few minutes after she and [redacted] talked [redacted] got text messages from [redacted]. JJ said she didn't talk to [redacted], but she talked to [redacted] friend [redacted] about what happened. I told JJ I was confused why there wasn't a call to [redacted] on her call log. JJ said she wished she would have left the call on her log. JJ said she was taking

screenshots of the call with [redacted]. I told JJ I was confused that the call with [redacted] was still on the log. JJ said [redacted] didn't want to be involved so she deleted the call. I asked JJ if she would be willing to let us get the information off of her phone and JJ said she was confused how that was relevant.

JJ said if [redacted] wanted to involve [redacted] that was her call and she didn't really know [redacted]. I told JJ she was the reason [redacted] and [redacted] met and said that [redacted] met [redacted] through [redacted] talking to [redacted] and that [redacted] knew [redacted] because of JJ. JJ said she knew who [redacted] was, but she didn't introduce them. I told JJ about [redacted] saying she met [redacted] on Instagram and JJ saying that he was her friend. JJ said she knew who [redacted] was, but didn't tell [redacted] to become friends with him. JJ said she didn't have a connection to all of them. JJ said she didn't know [redacted]. I told JJ they had texted and JJ said yes, but just to talk about [redacted]. I told JJ that it sounded like I could get some good information from [redacted] and [redacted] and asked what the best way to contact them would be. JJ said she didn't want to involve [redacted]. I asked JJ if [redacted] was a CSU student and she said he was. I asked JJ what he was studying and she said she wasn't sure and didn't know his major.

I asked JJ about the guys, and JJ said she only talks to [redacted]. JJ said she didn't know anything about [redacted] or [redacted]. I told JJ that I had all the information from [redacted] and [redacted] phones and that I had information requests out to Pinger. JJ asked me what Pinger is and I told her it is the texting app she was using to contact [redacted] and [redacted]. I told JJ I was giving her an opportunity to come clean and tell me about the guys. JJ said no and said she was trying to pick her words wisely. JJ asked if she could have ten minutes to calm down and she was very emotionally overwhelmed. I told JJ that [redacted] didn't exist. JJ ended the interview. I seized JJ's cell phone before she left the Police Department.

I spoke with [redacted] roommate [redacted]. I asked [redacted] she remembered a night during fall semester when [redacted] and JJ came back to their apartment. [redacted] said she was in her bedroom and heard them come in. [redacted] said [redacted] had a crush on the guy who had driven them home so she came in to tell her about it. [redacted] said [redacted] was drunk so she was mumbling and it took her a while to tell the story. [redacted] said after [redacted] talked to her JJ helped [redacted] up from the bed and helped her out of the room.

[redacted] said following that night she did not see or hear from [redacted] for several weeks and she became concerned for her. [redacted] said she went into [redacted] bedroom to check on her. [redacted] said [redacted] cried and was hesitant to tell her what happened. [redacted] said [redacted] told her she was really drunk and fell asleep. [redacted] told [redacted] she woke up to JJ touching her. [redacted] told [redacted] she was drunk and tried to roll over to get away. [redacted] told [redacted] that JJ said she wouldn't want to do this if she was sober. [redacted] told [redacted] she then woke up early and tried to make sense of the situation. [redacted] told [redacted] that JJ was apologetic afterwards. [redacted] said [redacted] was confused because the guys she was texting were telling her it wouldn't happen again and were sticking up for JJ. [redacted] said [redacted] was confused and conflicted about what to do.

I authored and submitted a Court Order Production of Records to Pinger for the account information for and content for the phone number [redacted] the phone number [redacted] and [redacted] were using to communicate with [redacted] and [redacted]. Pinger sent me information in response to my Court Order which I reviewed.

I discovered that seven IP addresses were used with this Pinger number. I looked these IP addresses up and discovered that three belong to CSU. I contacted the CSU IT employee who was listed as the contact person for the three CSU IP addresses. He looked up the IP addresses and told me all three addresses were assigned to Wi-Fi and the VPN Gateway on the CSU campus.

In the message logs I observed numerous contacts with [redacted] phone number [redacted]. Further in the past I observed numerous contacts with [redacted] phone number [redacted]. I also observed numerous contacts with the phone number [redacted].

In the message content I was able to read the actual messages to and from the number [redacted] for 02/20/2017-02/23/2017. All of the messages to and from this number were with the phone number [redacted]. This is the same phone number I saw come up numerous times in the Message Log.

I completed an online database search of this phone number and discovered that it was linked to [redacted] in Colorado Springs. I called [redacted] and [redacted] explained that I was investigating a case where her phone number had come up. I asked her if she could check her phone and tell me who the person associated with that phone number was. [redacted] told me this number belongs to [redacted]. I asked [redacted] who this person was and she said he was someone who had contacted her via Instagram and they had become friends. [redacted] said she has never met [redacted], but they have been texting each other daily for years. [redacted] said she would consider that they were dating. [redacted] said [redacted] abruptly stopped texting her about two weeks ago. I asked [redacted] if she could tell me [redacted] Instagram username and she told me he had taken his page down recently so she no longer had it.

I asked [redacted] if she knew someone named JJ Perez and she told me she did and that they had gone to high school together. [redacted] said JJ was friends with [redacted] said it was strange to her because JJ was the only person who she knew who knew [redacted] and who had seen him. [redacted] said she had never met [redacted] face to face. [redacted] told me that in high school JJ had been caught "cat fishing" her friend [redacted] creating a fake guy named [redacted]. [redacted] said [redacted] and JJ stopped being friends as a result of this.

In the Pinger customer information the name for the account is [redacted].

I authored and submitted a Court Order Production of Records to Instagram for JJ, [redacted] and [redacted] Instagram pages. I received and reviewed the information from Instagram from the Court Order I submitted.

I observed in the PDF of information on JJ's account that one of the CSU IP addresses I had seen in the Pinger court order was used on JJ's account. I observed in the PDF of information on _____ account that this same IP address and another one of the CSU IP addresses I had seen in the Pinger court order was used on _____ account.

I observed in the PDF of information on _____ account that the same CSU IP address was used. I observed that the email address given to create the account was _____ I also observed this email address in JJ's cell phone report in the passwords section. In this same Instagram document I observed that _____ account was closed on 02/28/2017 at 0320 UTC and the listed reason for the account being closed was "user initiated need break". (I interviewed JJ and seized her cell phone on 02/27/2017.) I read the message content between _____ and _____ during the date range of 02/21/2016 and 02/19/2017. In the conversations _____ and _____ share a lot of things about each other. _____ tells _____ that he is from _____ that he attends CSU, that he was _____

_____ I was not able to corroborate any of the information _____ gave about himself through online searches of this information.

Throughout the course of the message conversation between _____ and _____ they both express love and a lot of deep feelings for each other. There are several times in the conversation where _____ and _____ attempt to meet but there are circumstances that keep this from happening. JJ, _____ and _____ are all mentioned at different times in the conversation. In July 2016 _____ talks about losing his _____ and struggling with her loss. _____ is very sad for _____ throughout this portion of the conversation. Around this same time _____ tells _____ that he has purchased a necklace for her and that his sister helped him pick it out before she _____ This also makes _____ very emotional. In January 2017 _____ buys a puppy that he and _____ are supposed to help raise and take care of together. He sends several pictures of the dog and encourages her to help him pick a name for the dog.

I authored a Search Warrant for JJ's cell phone. Detective Jason Shutters completed a cell phone analysis on JJ's cell phone. He gave me a copy of the cell phone report generated from this analysis which I reviewed.

In the Passwords section of the report I discovered the email address _____ This is the same email address that was used to set up the Instagram page for _____ In the Installed Applications section of the report the Pinger Application is on the phone. In the User Accounts section of the report the Pinger account for _____ is on the phone. In the Contacts section of the report _____ are all listed as contacts on the phone. In the Notes section of the report are two notes. One is from 09/20/2016 and is a message written to _____ In the message she says that "what happened was wrong. But not because I did anything that at the time you weren't ok with." She then goes on to say "neither of us were ok with it sober." The second note is from 02/27/2017 and appears to be a sort of written statement about the pretext phone call

from [redacted] and the subsequent fight at the party.

The Chats section of the report shows the message content from the Pinger application conversations.

There is a chat conversation between [redacted] and [redacted]. This conversation goes from 09/14/2016 to 02/27/2017. [redacted] calls the person she is messaging [redacted] in the conversation. In the conversation they tell each other they love each other on numerous occasions.

There is a chat conversation between [redacted] and [redacted]. This conversation goes from 10/02/2016 to 10/24/2016. [redacted] calls the person she is messaging [redacted] in the conversation. In the beginning of the conversation there is reference made to now being able to text instead of communicate through Instagram. In the conversation they tell each other that they love each other several times. In the conversation [redacted] gets upset at [redacted] for not seeing her and for breaking plans they had to meet in person.

There is a chat conversation between [redacted] and [redacted]. This conversation goes from 09/11/2016 to 02/11/2017. [redacted] calls the person she is messaging [redacted] in the conversation. On 09/17/2016 at 2:12am [redacted] says "arr hou sober". At 8:57am [redacted] responds "Hey are you alright? I just got your text I was sleeping". [redacted] asks "if [redacted] had said anything about her and [redacted] responds "Not really. He said you weren't having a good day but didn't say why.. why? is everything okay?" [redacted] asks "did J (meaning JJ) say anything else about me??" [redacted] responds "Only when I ask questions haha. Why? She looked so bad after what happened and stuff so that's why I went to talk to her even though she tried to avoid me all night" [redacted] says "What? Damn that's a record for you guys!!! Haha I thought for sure you would be with her. Wait you haven't talked to her at all today? She didn't tell you about the crash????" [redacted] asks what crash and [redacted] responds, "The car crash? What the hell she didn't tell you? Ok what's going on there's something weird". [redacted] asks, "she got in a car crash?!" [redacted] responds, "Yes!!! And got a bad ticket and has to go to court and stuff. She was going 110 and was crying, she never told me why, in a 65 zone going to Denver and she probably totaled her cousins car. I'm hella confused can you please explain why you weren't the first to know about this?" [redacted] says, "damn but idk I didn't really talk to anyone today." [redacted] asks, "wait she was crying when she crashed the car?" [redacted] replies, "Yeah that's kinda why it all went down. She went to wipe her eyes and looked up and saw the cop and slammed on the brakes and like swerved into the other lane and shit idk. She looks likes she's not in good shape at all. Her eyes were hella swollen like she hasn't stopped crying and the bruising on her body is pretty bad. I'm thinking you might need to check on her lol". [redacted] says, "I would if I wanted to talk to her but I don't really want to m. I know why she was crying tho". [redacted] asked [redacted] if she thought she and JJ would mend things and replies, "I honestly don't know about me and J". [redacted] tells [redacted] "Alright alright..... well all I know is y'all better get over whatever it is real quick because you guys are too close for that fighting shit! Trust me, you don't want to lose your best friend. Way worse than any relationship break up". [redacted] replies, "I know I know but idk if this is

something I could get over." asks, "What the hell happened? Like can I not know? It's ok if not I just can't think of anything that would make you two stop being friends like damn."

There is a chat conversation between and . This conversation goes from 10/09/2016 to 02/19/2017. calls the person she is messaging In the messages and are flirty with each other. In the message and both express sadness about missing

In the Images section of the report I found the selfie that sent in her conversation to and a selfie sent to I found images of pictures I had observed on Instagram page and his message conversation with . I found images of screenshots of messages with I found screenshots of a Valentine's love message from to

I looked up and discovered this is from . I called and explained to her that I had found her phone number on someone's phone. I asked if she could tell me about said she went to high school with a girl who got her in contact with two guys. said one of these guys was said there was suspicion that these two guys were actually the girl, JJ. said this happened her sophomore year of high school and then supposedly the other guy, died. I asked about more recent contact with and she told me they had been talking, but it wasn't anything official. I asked when the last time she talked to was and told me she didn't know. then asked me if this was about I asked how she knew about and she told me that reached out to her on social media and told her she was opening an investigation involving JJ after she sexually assaulted her. said she told she didn't want to get involved.

On 04/06/2017 I spoke with JJ and her attorney. JJ told me she had not been completely honest with me when she had spoken with me before and wanted to clarify that. JJ explained that the night she and went back to apartment they had both been drinking. JJ said she was giving massage on her back and that had a knot in her back. JJ said asking if you could get knots on other places on your body, and JJ began rubbing stomach. JJ said leaned in and kissed her. JJ said things progressed from there and things happened. JJ said this was an awkward situation because they were such good friends and because they were not interested in girls. JJ said she was very clear in asking if this was something she wanted to do and she even asked if what she was doing felt good. I asked JJ what made what they were doing stop, and J.J. said that it just ended. JJ said she "fingered" and that she had not been truthful with me about this earlier.

I asked JJ about JJ told me she created and because she wanted to get a read on and JJ said she wanted to know what they were thinking of her as a friend and that this was a way to do that. JJ said

she then created [redacted] to have someone she was talking to because [redacted] and [redacted] were giving her a hard time that they were talking to [redacted] and [redacted] and she was not talking to anyone. I asked JJ about using [redacted] in another context, and she said she had used [redacted] in the past with a girl named [redacted] I asked JJ about [redacted] and JJ told me [redacted] was the name that she had used to create the account that was being used. JJ said she was using [redacted] to speak with a girl named [redacted] I asked JJ how she was able to keep track of all of the identities and told her that it was confusing given that she was talking to different people with different identities, and JJ said it just kind of made sense in her head.


I believe JJ Perez created and maintained the identities of [redacted] to have false romantic relationships with [redacted]
