I am a police officer for the City and County of Denver, Colorado, and have knowledge regarding the arrest/incident of the above named party for the below listed offense, which offense occurred on or about the date of 12/05/2017 at 1:45 pm at or near the location of 8400 PENA BLVD in the City and County of Denver, State of Colorado.

The probable cause of the arrest of the above-named individual is as follows:
[On 12/05/2017 at about 1345 hours Officers responded to the North Screening check point located at 8400 Pena Blvd, on a report of a loaded firearm, in lane #5.

TSA Agent Lorena Arias DOB 10/03/85, was working lane #5 and observed on the x-ray machine what appeared to be a loaded firearm in a bag belonging to Saine, Lori Ann DOB 10/14/74, who knowingly brought the handgun into the North Screening Check point.

A check of the bag revealed a Kahr Arms 9mm semi-auto handgun, serial #E19235, with 4 rounds in the magazine which was seated. there was not a round in the chamber.

Saine, Lori was placed into custody and taken to the AOB office for processing. An NCIC check of Saine and the firearm revealed no wants/warrants. Officer Zimmerman #00014 gave the suspect her Miranda Advisement. Saine requested an attorney and was transported to the DDC.]
